

# Terms of Use and Conditions for Association for Information Systems eLibrary

Welcome to the Association for Information Systems (AIS) eLibrary. Please carefully read these Terms of Use and Conditions (the "Terms") before using the services offered by the AIS eLibrary. By accessing or using the eLibrary platform, you agree to be bound by these Terms. If you do not agree with these Terms, please do not use the eLibrary services.

## 1. Acceptance of Terms

By accessing, browsing, or using the services provided by the AIS eLibrary (the "eLibrary"), you acknowledge that you have read, understood, and agree to be bound by these Terms. We reserve the right to change, modify, or update these Terms at any time without prior notice. Continued use of the eLibrary following the posting of changes means you accept those changes.
